**Note:**

This is a Varsity Team Camp. All player applications and payments must be submitted together. Please be sure to include the team roster – 1 per team and the team/coach’s information form. Teams will be accepted on a first come, first serve basis. All registration materials must be received by June 9.

Featuring:

This camp will be inviting high school Varsity teams to participate in league play followed by a tournament. Teams will be divided into balanced divisions based on team strength. The Pointer Women’s team will be demonstrating sessions on team offense and defense.

Coaches:

All teams must supply their own coach. WIAA rules now permit head coaches to work with their teams during the summer. If the head coach is unavailable, teams should provide an assistant or summer league coach to accompany their team at camp. Coaches are responsible for communicating any additional information to their teams before and during camp. Coaches will be provided with room and board.

Officials:

All games will be officiated by registered WIAA officials attending Becky Blank’s “You Make the Call” Officials Camp, which is run in conjunction with our team camp.

Facilities:

At Stevens Point we feel we have the best camp facilities in the Midwest. Berg Gym, home of the Pointer Women’s team and Quandt Fieldhouse, home of the Pointer Men’s team are both housed under one roof. This means no transporting campers from one site to another, no long walks across campus, and more time for basketball.

Insurance:

All campers MUST have their own health insurance or admission to camp will be denied.

Health History / Privacy Form:

It is required that each camper completes and has on file a UWSP Camp Health History Form and Notice of Privacy Practice. These forms will be available in your confirmation packet or online at: <http://athletics.uwsp.edu/sidebar.asp?id=501&path=wbb> Return the form to us as soon as possible. If we do not have the form on file, we can not allow the camper to participate in the basketball camp.

Deposit / Refund:

A \$100 deposit must accompany each player’s application. Each player must submit payment individually; one group payment WILL NOT be accepted. Checks can be made payable to UW-Stevens Point Women’s Basketball. Early cancellations due to medical reasons will receive a full refund minus a \$25 cancellation fee if the cancellation is made prior to camp. A camper departing camp due to an injury received at camp will receive a prorated refund minus a \$25 cancellation fee. All other cancellations will receive payment back minus a \$50 cancellation fee if notification is made two weeks prior to the start of camp. No refunds will be given for no shows or camper sent home for breaking camp rules.

Confirmation:

Upon receipt of a team’s application materials (team roster, coach’s information form and ALL players’ application forms and payments), a confirmation packet will be mailed to each player and camp coach.

Room / Board:

Resident campers will be housed two to a room in a residence hall on the UWSP campus. Campers receive constant supervision as counselors and coaches room on the same floors. Meals will be provided from local restaurants.

Commuters:

Commuters are campers who elect not to stay in the residence hall. Commuters do not eat breakfast on campus but will be provided with lunch and dinner.
